In case bidder does not turn up within 10 days from the date of finalization of bid to take the delivery of the material an amount @ of 2% of the auctioned value per day will be charged as ground rent for next fifteen days and after that the deposited amount shall be forfeited in favour of AMU, Aligarh. Weighing of the auctioned material shall be made at Dharm Kanta at the cost of purchaser in the presence of the representative of the Building Department. The remaining 75% of the offered amount of the auctioned material must be deposited in the Central Purchase Office before weighing the auctioned material through Demand Draft. **The auction committee reserved the right to accept or reject any or all offers or postponed the auction without assigning any reason.
